Dear Taxpayer:

We're responding to your request dated Mar. 20, 2024, about your tax-exempt status.

We issued you a determination letter in October, 1992, recognizing you as tax-exempt under Internal Revenue Code (IRC) Section 501(c) (3).

- Form 990-PF, Return of Private Foundation or Section 4947(a)(1)
  Trust Treated as Private Foundation

According to IRC Section 6033(j), if you don't file a required annual information return or notice for 3 consecutive years, we'll revoke your tax-exempt status on the due date of the 3rd required return or notice.
